Sub- Disclosure under Regulation 30 SEBI (LODR) Regulation 2015 regarding the Intimation of the fire at external warehouse

Scrip Code – 530255, Scrip ID - KAYPOWR

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”), we hereby inform that a fire incident was reported at the Company’s premises located at Gat No. 454/457, Village Borgaon, Satara – 415519.

The fire occurred in the Company’s external open storage facility used for the storage of wastepaper, which is utilized as a raw material in the manufacturing process, and also affected certain machineries installed adjacent to the storage facility.

As per the preliminary information available, the fire originated from the adjacent premises of an agricultural school and subsequently spread to the Company’s external open storage facility used for the storage of wastepaper, as well as to some nearby machineries. The exact cause of the fire is yet to be ascertained.

The fire was promptly brought under control by the Company’s internal team using the in-house firefighting systems. No human casualties or injuries have been reported.

The raw material stock and machineries at the affected location is adequately insured, and the Company has already intimated the insurance company regarding the incident. An insurance survey is expected to be conducted in due course to assess the extent of the loss.

Further, the details as required under Regulation 30(6) of the Listing Regulations read with SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated 11 November 2024 (including amendments thereto) are provided in Annexure – I.
